- 1. Call to Order Bill Penner called the meeting to order at 12:08 p.m.

- 4. New Board Members
 - Bill Penner welcomed new board members Scott Penner and Keith Stoesz.
 - Alvin Ginter declined the board seat. Board will continue to look for an additional member.
- 5. Reorganize Committees
 - Bill Penner accepted the role of president for a second term.
 - Chris Sumner accepted the role of vice-president.
 - The new sub-committees for 2017-2018 are: asset development Loren and Wendy; granting – Keith, Scott and Brenda; public relations – Chris, Bill and Brad.
- 6. Financial
 - Rhineland Child Care did not submit enough invoices for the total project cost of their 2016 spring grant.

- 8. Altona & District Health Board Update
 - A letter was sent to the Altona & District Health Board for clarification on what type of fund they wanted the Altona Hospital Fund and the Dr. Toni Scholarship Fund to be set up as.
- 9. Giving Challenge Update
 - Received notification from the Province of Manitoba that they will also be stretching funds for community foundations during the 24-Hour Giving Challenge on November 18.
 - Chris to touch base with Melissa about the ACF Live Action Broadcasts on that day.

10. YIP Update

- Chris invited the YIP student reps to the ACF October board meeting invitation was declined.
- Chris offered to attend a student council meeting to re-outline what the YIP program is all about.
- Laura Thiessen from W.C. Miller reported that student council held their first meeting of the year and decided they would like to hold off on thinking about YIP until January.
