- 1. Call to Order Chris Sumner called the meeting to order at 12:06 p.m.
- Review of the Agenda MOTION: Bill Penner – moved – Tracy Klassen – seconded – THAT the agenda is approved as presented. CARRIED.
- Review of Previous Minutes MOTION: Wendy Dyck - moved Brenda Thiesen – seconded - THAT the minutes of the meeting held February 22, 2019 are adopted as circulated. CARRIED.
- 4. YIP
  - School was cancelled so YIP was unable to attend.
  - YIP reported via email that they raised \$250 at their movie night fundraiser.
  - They are working towards a soup and pie fundraiser on April 11 (pending on enough donations from the community calls that will be going out next week).
  - YIP is also working towards having their grant application form sent out the first week of April to possible community groups.

  - Chris presented a draft of an Administrative Recovery Fee Policy to the board.
  - Discussion entailed, Chris to revise the draft and present at the next meeting.

- 7. Community Foundation of Canada invitation
  - CFC has extended an invitation to community foundations to embark on collaboration in support of youth leadership and community vitality. The ACF has until March 29 to submit an expression of interest.
  - Chris to review the invitation and respond by the deadline.
- 8. Menno H. Friesen Fund
  - As per the motion made at last month's meeting Wendy confirmed the Menno H. Friesen Fund was transferred to a 55-month GIC.
  - Bill confirmed with the family that the fund will grant money in the fall.
- 9. Altona Chamber Banquet
  - Prizes have started to come in for the silent auction members to communicate via email on any additional prizes that are donated.
  - Tim Spiller is asking the ACF if a board member would like to bring greetings at the banquet Chris to confirm.
- 10. Public Relations Report
  - Jennifer confirmed with the board to book print and radio ads for the 2019 spring granting period at a cost of: print \$335 and radio \$416.
