

Minutes of the Altona Community Foundation (ACF) Board of Directors meeting held on Wednesday, May 10, 2023.

Present were: president, Haydon Friesen; vice president, Keith Stoesz; treasurer, Angus Klassen; Vic Loewen; Jonathan Toews; Ken Wiebe, Al Friesen, Cheryl Dueck and Shauna Giesbrecht.

- Call to Order Haydon Friesen called the meeting to order.
- Review of the Agenda MOTION: Vic Loewen - moved – Ken Wiebe – seconded - THAT the agenda is approved as presented.
 CARRIED.
- Review of Previous Minutes
 MOTION: Vic Loewen moved Keith Stoesz seconded THAT the minutes of the meeting held
 April 12, 2023 are adopted as circulated.
 CARRIED.
- Welcome new board member
 - The board welcomed Shauna Giesbrecht to the board.
- Financial
 - Angus submitted \$260.70 in receipts: QuickBooks purchase, \$140.70 and corporate filing returns from 2021-2023, \$120.
 - Angus presented the attached financial reports to the board prior to the meeting.

MOTION: Angus Klassen – moved – Ken Wiebe – seconded – THAT the attached financial reports are approved as presented.

- Granting committee
 - 2023 spring granting: 10 applications received, 8 were accepted and two were denied.
 - Board had \$30,000 to disperse.
 - Keith went through the grant scoring guide with the board.
 - Board confirmed the following \$29,000 in grant requests:
 - AAFRC, \$1,125 pd training
 - o Altona Minor Baseball, \$6,375 baseball diamond retrofit
 - Children's Rehabilitation, \$3,000 tricycle
 - Katie Cares, \$1,000 Beanie Babies
 - Kiddie Sunshine Centre, \$4,250 play kitchens
 - STARS, \$2,000 human patient stimulator
 - The Gardens on Tenth, \$1,000 courtyard chairs
 - TransCanada Trail, \$5,250 seeding tallgrass
 - Kiddie Sunshine Centre allocate \$5,000 for 2023 fall payment for 2022 daycare expansion grant

MOTION: Angus Klassen – moved Jonathan Toews – seconded – THAT the ACF amend the presented 2023 grant scoring guide and approve a grant payment to Katie Cares of \$1,000 from \$500 and approve the rest of the 2023 spring grant requests as presented. **CARRIED.**

- Letters and grant check sheets to be mailed to approved and declined grant applicants.
- Press release to be sent to media.
- The board clarified the grant distribution terms over the next five years for the Kiddie Sunshine Centre daycare expansion grant. A \$10,000 cheque has been issued for the 2022 grant installment. For the remaining years 2023 – 2026, \$10,000 will be paid out after the fall granting period (November 1) when the funds allocated to this grant are available for pay out. Kiddie Sunshine Centre will submit a min. of \$10,000 in receipts to the ACF each year related to the daycare expansion (before Nov. 1) in order for us to fulfill our CRA requirements.
 - o 2022 grant installment, \$10,000 cheque is being issued
 - o 2023 grant installment, \$10,000 payable after November 1, 2023
 - 2024 grant installment, \$10,000 payable after November 1, 2024
 - o 2025 grant installment, \$10,000 payable after November 1, 2025
 - o 2026 grant installment, \$10,000 payable after November 1, 2026
- YIP
 - YIP raised \$800, and with matching funds from the ACF they had \$1,600 to disperse.
 - YIP announced their 2023 grants recipients: Katie Cares, \$200; Altona Curling Club, \$500; Altona & Area Family Resource Centre, \$200; The Gardens on Tenth, \$400 and Altona Girls Minor Softball, \$300.

MOTION: Cheryl Dueck – moved Angus Klassen – seconded – THAT the ACF approve the 2023 grant recipients as selected by YIP.

- Richard Neufeld Legacy Fund
 - Angus has consulted with Loren about the fund agreement wording. Will send a draft to the board to approve.
 - Donor still needs to submit an objective.
- ACF Ag Scholarship Fund
 - To date, no applications received; deadline is May 31.
- Altona Chamber Banquet
 - Raffle generated \$1,940 and the silent auction generated \$1,800.
 - Next year review increasing the number of tickets for the price point.
 - Build awareness of the raffle/auction through our social media, display our easel encourage people to bring cash, or next year look at some kind of electronic payment option.
 - Ask the sunflower queen/princesses to assist w/raffle sales good opportunity for them to mingle.
 - Prize donors were sent thank you notes along with their donation receipts.
- Public relations committee
 - PR committee presented a 2023 budget proposal to the board.
