

Minutes of the Altona Community Foundation (ACF) Board of Directors meeting held on Wednesday, November 8, 2023.

Present were: president, Haydon Friesen; treasurer, Angus Klassen; Vic Loewen; Al Friesen; Cheryl Dueck; Shauna Giesbrecht; Leanne Braun and Ralph Hamm. Regrets: Jonathan Toews.

1. Call to Order

Haydon Friesen called the meeting to order.

2. Review of the Agenda

MOTION: AI Friesen - moved – Shauna Giesbrecht – seconded - THAT the agenda is approved as presented. CARRIED.

   MOTION: Ralph Hamm moved Leanne Braun seconded THAT the minutes of the meeting held October 18, 2023 are adopted as circulated.

- 4. Board Vice Chair

• At last months meeting no board chair was appointed.

MOTION: Vic Loewen – moved – Ralph Hamm – seconded – THAT AI Friesen be appointed as vice chair of the ACF. CARRIED.

- 5. Financials
  - The following cheques/payments were issued: 2023SG KSC, \$10,000; 2023 YIP grant to ACC, \$500.
  - E-transfer payment was made to Jenn, \$134.68 lunch, domain renewal, and Google Workspace.
  - Angus to apply for an ACF M/C with a \$10,000 limit.
  - Angus presented the attached financial reports to the board prior to the meeting.

6. Granting Committee

• 2023 fall granting: 18 applications were received, 15 were accepted and three were denied. **MOTION: Vic Loewen – moved – Angus Klassen – seconded – THAT** the ACF move \$5,000 from surplus operating into interest for granting.

- Board had \$48,903 to disperse \$46,950 from interest for granting and \$1,953 from the Menno H. Friesen Fund.
- Vic went through the grant scoring guide with the board.
